

## **CONFIDENTIALITY DECLARATION**

### **ARTICLE 1 - PERSONAL INFORMATION COLLECTED**

When you make a purchase from our Site, as part of our buying and selling process, we collect the personal information you provide to us, such as your name, number and email address. But these are only used in the purchase process and its data is automatically deleted 30 days after the purchase process is completed.

When you browse our site, we do not receive or collect any information about your computer's Internet Protocol address (IP address), or information about the browser and operating system you are using.

### **ARTICLE 2 - CONSENT**
